



# Competition Rules 2020



## Part 1

### 1 General

- 1.1. These rules govern entry in the Welsh Pétanque Association's (WPA) National and Qualifying competitions, herein after referred to as "competition" or "competitions".
- 1.2. Entry into any WPA competition indicates acceptance of these rules by all individuals entering the competitions, whether by self-entry or being entered by the captain of a team.

### 2 Governance

- 2.1. The number, dates, rules and venues of the events will be determined by the WPA Executive and published in advance.
- 2.2. The WPA Executive will be responsible for the organisation of the competitions and will appoint an Organiser for each event.
- 2.3. The WPA Executive will appoint, when possible, an Umpire for each event.
- 2.4. The Organiser of each event will be the representative of the WPA Executive and may, in the event of any dispute not covered by the rules, after consultation with the Umpire, appoint a Jury of at least three WPA members. The decision of such a Jury will be final.
- 2.5. Regulations for play shall be the "Official International Rules of the Game of Pétanque" and any variations set out in these "Competition Rules", or as announced by the Organiser on the day.
- 2.6. Any event may be cancelled at the discretion of the WPA Executive.
- 2.7. Competitions held at venues that are commercial, such as public houses and sports clubs, may only allow food and drink purchased at the venue to be consumed. All players are to respect this and comply with venue regulations or may be subject to an immediate disqualification from the competition.

### 3 Eligibility

- 3.1. WPA members holding a valid and legible licence, which must include a recent photograph of the holder, are eligible to compete in all competitions, subject to the following additional eligibility conditions.
  - 3.1.1. Each player entering the Veterans Triples Championship must be aged 55 years or over at the time of the event.
  - 3.1.2. Each player entering the Women's Singles, Doubles, Triples or Precision Shooting Championship must be an adult member.
  - 3.1.3. Each player entering the Men's Singles, Doubles, Triples or Precision Shooting Championship must be an adult member.
  - 3.1.4. Juniors may enter the National Competitions providing there is no Junior equivalent competition held in that playing season.
- 3.2. WPA members wishing to enter the qualifying process to represent Wales in World or European Championships must, subject to the Executive Committee's discretion, have been a member of the Association for a minimum period of one year prior to the first Qualifying event in any membership year.

### 4 Entries

- 4.1. All competitions shall be by pre-entry.

- 4.2. The WPA reserves the right to refuse entry into any of its competitions.
- 4.3. The dates of all competitions will be notified to members via the WPA calendar published on the WPA website.
- 4.4. Pre-entry forms, online or hard copies must be completed using the designated form:
  - 4.4.1. Domestic Representation Events (Celtic Challenge, Home Nations, Pétanque England's (PE) Inter-Regional Championship).
  - 4.4.2. World and European Championship Qualification
  - 4.4.3. Pre-entry Form - All other WPA National events.
- 4.5. The pre-entry form must be submitted to the WPA Executive prior to the closing dates for competitions indicated on the form. All parties' attention is drawn to the form submission rules (printed on the form itself).
- 4.6. The captain of a team may act on an individual's behalf and enter the team for a competition. Captains must obtain the permission of the individual before entering them into a competition (Rule 1.2).
- 4.7. Entry forms (hard copy) and cheques, payable to the Welsh Pétanque Association, for the correct entry fee are to be sent to the address published on the entry form and to arrive by the published closing date. No allowance will be made for delays in the postal service.
- 4.8. If a team or individual has pre-entered a competition and then find they cannot attend, they must withdraw by notifying the WPA Executive.
  - 4.8.1. If the withdrawal is before the closing date, then a refund of fees may be given.
  - 4.8.2. If the withdrawal is after the closing date, no refund will be given unless extenuating circumstances for withdrawal can be shown.
- 4.9. Entry to non-qualifying competitions will be accepted on the day at the organisers' discretion and with the provisos that:
  - 4.9.1. There is room to accommodate the late arrivals in the competition.
  - 4.9.2. The organisation will not be unduly affected by the late entry.
  - 4.9.3. The team is required to pay the entry fee and an additional fee of £3.00 per player.
  - 4.9.4. The WPA or the Organiser of the day has complete discretion to decline to use a team name and without giving a reason and can instead replace it with another name or number, usually the name of the team captain or first named player.

## 5 Entry Fee

- 5.1. Entry for events is £7.00 per player. Entry is free for Junior players playing in adult competitions when there is no specific junior competitions organised by the WPA
- 5.2. Payment of the relevant entry fee can be made by post, electronically or on the day of the event.
- 5.3. For an entry to be valid, full payment must be received.

## 6 Registration and Draw

- 6.1. Registration will open by 09.00 and close promptly at 09.30. Any changes to these times will be published in advance.
- 6.2. All players will register as a valid team as defined in Article 1 of the "Official International Rules of the Game of Pétanque" at the control desk. At the Organiser's discretion, players may be asked to present their licences at the time of Registration. The team captain is required to notify the Organiser immediately, and before the close of registration if a member of the pre-entered team will not be able to register with a valid reason.

- 6.3. Any player failing to produce a valid licence on request of the Organiser may be fined £7.00, and may be refused entry to the competition.
- 6.4. By close of registration only those teams, who have properly registered, as defined above, will be permitted to take part in the competition.
- 6.5. The draw will take place in the presence of the Umpire or two team captains selected at random from the registered teams.
- 6.6. Play will commence as soon as possible after the completion of the draw and announcements.
- 6.7. In accordance with the Official Rules, a team may start play with one or more players short if the player or players are unavoidably detained. The Official Rules explain how and when the missing player(s) can join in. The player(s) actually starting cannot throw any more boules than they would if the whole team was present, that is if two players are present then 4 boules, if one player then 2 boules, until the missing player(s) are permitted to join in.

## **7 Competition Format**

- 7.1. The Organiser of the day, after consultation with the Umpire (if present), has the right, subject to the number of entries, to alter the format of play, which may include timed games.
- 7.2. A lunch break may be held at the discretion of the Organiser and Umpire (if present). In this case the Organiser and/or Umpire will blow a whistle to start the break, which will be for approximately 30 minutes. The end in progress must be completed, with no players allowed on the terrain during this break. The Organiser and/or Umpire will blow a whistle to indicate the re-start of play.
- 7.3. The playing format for WPA National Singles, Doubles, Mixed Doubles, Triples, Veterans Triples Championships and other open competitions organised by the WPA, will be, subject to the number of entries.
- 7.4. The Domestic Representation Series will consist of 4 sets of competitions. The preferred format for these events will be the Swiss System using the Fine-Buchholz Number (fBHN); the results shall be combined to decide the final ranking of the registered teams.
- 7.5. The Domestic Representation Series is used to qualify and place in order teams for the Domestic Representation events; Home Nations, Pétanque England (PE) Inter-Regional Championship and Celtic Challenge, up to the required number of teams in each event. Teams may be mixed or all the same gender and may include Junior players.
- 7.6. If the minimum required number of teams (8) is not reached during the Domestic Representation Series, the WPA will decide if it is appropriate to call on players who did not take part in the Series to reach the minimum number of required teams or will withdraw from the event.
- 7.7. The Welsh Cup for Clubs Competition will be conducted under the published rules issued specifically for that event

## **8 4th Team Member (Substitute)**

- 8.1. A 4th Team Member will be allowed within the WPA competitions except under rule 8.1.1.
  - 8.1.1. Substitutes cannot be accepted in the National Singles, Doubles and Mixed Doubles competitions.
- 8.2. An individual can be named as a 4th team member by one team only.
- 8.3. The common practices of the FIPJP will be used for the deployment of 4th team member (substitutes) during play.

- 8.4. Teams can name a 4th team member, but the 4th team member does not have to be present at each qualifier. However, 4th team members must be fully paid for, whether or not they attend the first qualifier.
- 8.5. The 4th player must be registered with the team, see Article 6.2. Failure to register the 4th player will result in that player being unable to participate in the days play.

## 9 Standards

- 9.1. When playing in all WPA competitions, players within a team will be required to wear matching tops. A 'top' may be a shirt, polo shirt, T-shirt, fleece, jacket, blouson, jumper or any similar garment. 'Matching' is defined as of the same colour and design.

At this time, the WPA does not require players to enter competitions wearing matching playing bottoms. When playing in a representative capacity for the WPA, players will be required to wear the approved team kit for those events.

No official WPA-representative "tops" shall be allowed to be worn (those tops worn for World Championship, European Championship, Celtic Challenge, Home Nations Championship and Invitations, including the PE Inter-Regional Championship).

- 9.2. In the event of inclement weather, waterproof tops and trousers may be worn; these do not need to be matching.
- 9.3. All players are to wear enclosed footwear.
- 9.4. Any player failing to comply with the standard of dress will be fined £10.00, and may be disqualified from the competition.
- 9.5. At all WPA Competitions, the drinking of alcohol, smoking, vaping or the use of mobile hand-held devices by competitors is forbidden during play, and within the designated playing area.
- 9.6. Although "banter" is an accepted part of the game, and the WPA wants players to enjoy themselves when playing, players must adhere to the standards of behaviour laid out in Articles 17 & 18 of the "Official International Rules of the Game of Pétanque", with respect to the position they stand in and noise they make when their opponents are playing, as well as "practicing" when a game has started.

## 10 Qualification

- 10.1. The qualification process for Domestic Representation is as described above (Article 7.5) for the Celtic Challenge, Home Nations and the PE Inter-Regional Championship, if the WPA is invited to attend.
- 10.2. The process for other international championships is by qualification in the relevant WPA World and European Championship Qualification Series. The detail of the latter process is set out below and in further detail in Part 3 of this document.

## 11 International & National (Domestic) Representation

### 11.1. International Representation

- 11.1.1. For both the Men and Women Triples World & European Championships, the WPA need to qualify 4 players, one of whom will also take part in the precision shooting competition. The top 4 ranked players will qualify to represent Wales, with the Player taking part in the Shooting Competition to be decided prior to the Championships.

- 11.1.2. For the Veterans' European Championships, the WPA is required to qualify 4 players; there is no precision shooting competition at this event. The top 4 ranked players will qualify.
- 11.2. Domestic Representation
  - 11.2.1. The top 8 placed teams from the Domestic Representation Series, Rounds 1 & 2, will be invited to represent the WPA at the Home Nations Championship.
  - 11.2.2. The top 8 placed teams from the Domestic Representation Series, Round 3, will be invited to represent the WPA at the PE Inter-Regional Championship.
  - 11.2.3. The top 4 (or 8, when held in Wales) placed teams from the Domestic Representation Series, Round 4, will be invited to represent the WPA at the Celtic Challenge.
- 11.3. Membership of the WPA demands that players who qualify to represent Wales in ANY competition (domestic or international) will be expected to agree to abide by the conditions set out in the Contract of Representation (Part 4). Entry into the competition is taken as the player's acknowledgement that they have read and agree to abide by the terms of the Contract of Representation. Players may be asked to sign a copy to confirm their agreement. The same expectation will extend to Heads of Delegation and Coaches/Team Managers.
- 11.4. Players' attention is drawn to the fact that they are likely to have to meet all costs associated with representing the WPA at ALL International or Invitational events for which they qualify, as defined in Part 3.

## 12 Authority

- 12.1. Where the competition is disrupted by teams or players being absent on the day or leaving before completing all their games, the Organiser, in consultation with the Umpire (if present), may call the Jury and request a change of the format of the competition and these Rules as appropriate, and in any case the Umpire (if present) and/or Organiser must make a full report to the WPA Executive within 24 hours.
- 12.2. Any infringement of these Competition Rules or the Official International Rules of the Game of Pétanque will be reported to the WPA Executive and may invalidate entry, resulting in disqualification, may lead to disciplinary action and/or necessitate the forfeiture of any position or prizes previously awarded.
- 12.3. During any event, the Umpire (if present), the Organiser or Jury are responsible for the interpretation of these rules.

## Part 2

### 1. Post Qualification for Domestic Representation Series for the Home Nations, Celtic Challenge and Inter-Regional Championships

- 1.1. Qualification to represent the WPA will be attained by teams and not by individuals.
- 1.2. Players shall be required to represent the WPA at the events for which they qualify.
- 1.3. Players are to ensure that they are available to play at the qualifying event and to the best of their knowledge will be physically able to complete the qualifying event before entering.
- 1.4. The results attained at the qualifying event will be final for the purposes of qualification.
- 1.5. Teams that qualify will be those that have met the qualifying criteria at the end of the event.
- 1.6. For the event, where a three-player team does not have a substitute, another player can be called upon who has played in the qualifying competition, but who has not qualified themselves or they may also use a substitute from another team who played in the qualifying competition with the permission of that team. Where a team qualifying does include a 4th team member, the entire team will qualify.
- 1.7. Between qualification and the event, if a team should lose players (e.g. a three-player team loses one player and a four-player team loses one or two players). The team may then choose to:
  - 1.7.1. A four-player team that loses up to two players may similarly elect one or two replacements who played in the qualifying competition, but who did not qualify themselves. A substitute from another team(s) who played in the qualifying competition may also be used with the permission of the affected team(s).
- 1.8. Where a team of three loses two players or a team of four players loses three players a reserve side may be called into represent the WPA. This will be the team that came immediately below 'the cut' in the qualifying event. Teams in the reserve pool will be drawn-from in the order in which they finished the qualifying event. Where possible, the reserve team may be encouraged by the WPA and should endeavour to include the remaining player(s) from the originally qualified team.
- 1.9. The positions at which the teams qualify may not be the final positions at which they will play. The WPA Executive and/or the Coach/Team Manager may decide placement of qualified teams for some events, if they consider it is in the best interest of the National Team.
- 1.10. The WPA Executive reserves the right to select teams in exceptional circumstances, e.g. insufficient qualified teams are available for an event. (Precedent being: Home Nations, Scotland, 2001) or to withdraw from the event.
- 1.11. Once entered, teams are expected to attend. Entry to qualifiers indicates that individuals and teams are available to represent the WPA. The event details appear on the pre-entry form at the bottom of the event boxes. Qualifying teams or individual players must be able to attend the events they indicated they would attend. Failure to attend a competition for which a team or individual has qualified may result in disciplinary action and subsequent sanctions.

## Part 3

### Teams entering qualifying events for the World and European Championships.

#### 1. Introduction:

- 1.1. The WPA will provide the mechanism for qualifying the teams to represent Wales in World and European Championships.
- 1.2. Qualification to represent the WPA will be attained by individuals and not by teams.
- 1.3. Individuals wishing to enter the qualifying process to represent Wales in the World or European Championships must, subject to the Executive Committee's discretion, have been a member of the Association for an uninterrupted minimum period of one year prior to the first qualifying event, as outlined in Part 1, Article 3.2, above.

#### 2. Qualification Process

- 2.1. The Qualification Process will be conducted under specifically published specifications.
- 2.2. Team Managers/Coaches/Heads of Delegation will be appointed by the WPA Executive for each team but in consultation with each team, and will make such appointments at the earliest opportunity after the qualifying event
  - 2.2.1. Once appointed, the Coach/Team Manager and Head of Delegation are considered part of the Team along with the players and as such will be subject to the same conditions within the Contract of Representation as the players.
  - 2.2.2. Any Coach/Team Manager to be appointed must agree to commit to the support of the team for which they are responsible, and be willing to attend events at which the team concerned is training, or competitions which it is taking part in as preparation for the relevant championship
  - 2.2.3. Team Managers or Coaches are expected to brief players at the end of each match, and where statistics or other performance guides are taken to be able to provide the relevant information to the players as part of such match de-brief, or as soon as possible after the match.
- 2.3. It is expected that all qualified players will attend training and preparation sessions organised by the WPA. Where possible the representative teams will be offered opportunities to play in competitions outside Wales as preparation for the championship.
  - 2.3.1. Players who took part in the Qualification process but who are not invited to play for Wales in these championships may be offered the opportunity to play in other competitions and represent Wales as appropriate.
  - 2.3.2. The WPA provides a level of financial assistance to Team Managers/Coaches and Heads of Delegation and will endeavour, as described below, to provide some level of financial assistance to all Players, attending competitions in preparation for these Championships, and the Championships themselves.
  - 2.3.3. Qualifying players must expect to have to find their own funding. Those teams that qualify and agree to represent Wales will be given financial support of up to £100 per player, at the discretion of the WPA Executive Committee.
- 2.4. The highest standards are expected of those members representing Wales, and should be aware of the terms of their contracts and of the disciplinary procedures which are available to the WPA, and on the recommendations of the FIPJP and CEP.

## Part 4

### Contract of Representation.

The following Contract provides all players representing their country with the standards of behaviour that are required to ensure that Wales and the Welsh Pétanque Association (WPA) is highly regarded by the competing nations and the organisers of competitions and the associated activities.

This Code is to be taken seriously but is not intended to prevent you from having an interesting and enjoyable competition. You are there to produce the best possible results for Wales and the WPA, which should in itself provide you with the interest and stimulation required.

As players and officials, you are representing your country, which is a major honour and consequently you are in the spotlight. Your good performance and conduct will be taken as a role model by less experienced players. However, the potential to do harm to the game is considerable if you do not demonstrate the skill, sportsmanship and conduct that is expected, and which helped you to achieve your place in the Team.

You are a recognised member of the Welsh team from the moment that the group meets until it disperses after the competition. A professional conduct is expected and will be maintained at all times.

#### 1. TIME KEEPING.

It is your responsibility to ensure that you report on time at any occasion when stipulated. Any time notified should be considered as the latest time of reporting. Lateness is not acceptable as it results in the whole team being delayed. Should you not attend the event for any reason then you may be liable to reimburse the WPA for all monies they may have laid out in booking travel, accommodation and team kit and any other reasonable expenses deemed appropriate.

#### 2. DISCIPLINE.

The Head of Delegation and Coach/Team Manager have delegated authority from the WPA to have the final say in all matters relating to the conduct of the Team. They consequently have the authority to exclude players from all or part of the competition if the Contract of Representation is not observed, or to take other disciplinary action that may be appropriate at the time or at a later date if evidence of alleged misconduct is later discovered.

#### 3. BEHAVIOUR.

You are expected at all times to show respect and consideration to your team members and Welsh officials and supporters, the Competition Organisers, all other players, and all spectators. You are clearly expected to observe all the rules of the sport and the competition or tournament, including proper attendance at any opening or closing ceremonies. You are not, by any action or comment, to do anything that could bring the WPA into disrepute. Any inappropriate behaviour may result in your exclusion from representing the WPA in the future.

## **4. ALCOHOL. [See Supplementary Note 1]**

Alcohol does not assist long-term performance and should be restricted to reasonable drinking when accompanied by food. In all representative competition consumption of alcohol during the event by Welsh team participants is forbidden during play. Strict alcohol limits are set for the European and World Championships and enforced by random testing during the event.

## **5. DRUGS.**

The taking of any illegal drugs whatsoever is banned. If any player has taken any medication in the 3 months prior to the event including non-prescription medicines, the details must be notified to the WPA Medical Advisor in advance and written evidence from the prescribing doctor must be provided.

## **6. SLEEP.**

In order to maintain the concentration and mental awareness required by our sport over a long duration, it is essential that a full night's sleep is obtained before each day's play.

## **7. TEAM STRIP.**

Where required you will be provided with Team Strip to be worn at all stages of the competition and at prescribed events.

## Supplementary Note 1

### Alcohol in designated WPA competitions and all International competitions.

This note provides further information for players on the WPA Code of Conduct for Players competing to represent Wales or playing for Wales in international competitions, and in any designated National Competitions to which the Code applies.

**1.** Drinking alcohol is a breach of the Code if done while a player is playing, or where the player as the 4<sup>th</sup> or reserve player is waiting to play; likewise, the drinking of alcohol by a player in any area designated by the organisers as one where alcohol is not permitted and is a breach whether or not the player or his or her team is actually playing at the time.

**2.** Testing for breath alcohol. The WPA may conduct either random tests using a breathalyser; or if deemed appropriate or necessary where the organisers or the Umpire have reasonable grounds for believing a player has consumed alcohol in breach of 1 above, or has or may have consumed alcohol which does or may exceed the WPA's safe alcohol limit (which is the same standard as that recognised by law for "drink driving" safety in England and Wales).

**3.** Refusal to take a breath alcohol test except for good and acceptable reason, such as a relevant declared medical condition, may also be a breach of the Code.

**4.** The consequences of a breach of the Code are:

Consequences of Code violations include imposition of penalties. These can include one or more of the following depending on the circumstances:

A warning from the Umpire.

A second warning during the competition/ and/ or

- **removal from the competition**, with a subsequent investigation which may impose a period of ineligibility to play.

Other possible consequences include:

- **Disqualification:** Player's results in the competition are invalidated.
- **Ineligibility:** Player is barred from events for a specified period of time.
- **Provisional Suspension:** temporary bar pending a final decision at a hearing.
- **Financial Consequences:** imposition of a financial sanction to recover the cost of the anti-doping investigation.
- **Public Disclosure or Public Reporting:** Putting the final decision in the public domain – but **only after** any appeal has been dealt with which upholds the finding of a violation."
