THE EUROPEAN PETANQUE CHAMPIONSHIPS 2022

The European Petanque Championships Singles and Doubles will be held in 's-Hertogenbosch from 13 to 17 July 2022. The European Championships are organized by a combination of partners: the Dutch Petanque Federation (NJBB), the municipality of 's-Hertogenbosch, BrabantSport, the Ministry of Health, Welfare and Sport, NOC*NSF and sports events agency Team TOC.

WHERE?

The European Petanque Championships 2022 will take place at the Parade in 's-Hertogenbosch. On the famous square, 22 covered petanque courts will be built, where the best petanque players in Europe will compete for the European titles in the categories tête-à-tête (men and women), doubles (men, women) and mixed (man/woman). In addition to the competitions, you can enjoy good food, drinks and music.

EC PETANQUE IN THE FIGHT AGAINST LONELINESS

The social spin-off of the event is also very important. One of the objectives of the European Petanque Championships 2022 is to reduce loneliness. By organizing a tournament for all residents of the city, among other things, sport is used to strengthen social cohesion in the neighbourhoods.

50TH ANNIVERSARY NJBB

In 2022, the Dutch petangue federation (NJBB) will celebrate its 50th anniversary. The European Championships are a wonderful way to celebrate this milestone. With the organization of this event, the NJBB hopes to arouse more interest in the fantastic sport and show that it is suitable for everyone.

CONFÉDÉRATION EUROPÉENNE DE PÉTANQUE

The Confédération Européenne de Pétanque (CEP) is the Continental confederation for the sport of petanque in Europe, with its registered headquarters located at the FLBP National boulodrome in Luxembourg. The CEP organizes various tournaments, World Cups and European Championships throughout Europe. These tournaments focus on the different disciplines within the pétanque sport.

to uniteration or Administered by a team of 11 Directors, each from a different European federation, the CEP currently has a membership of 40 federations who together represent 8627 clubs and almost 400,000 individual members, making Europe the largest of the 5 continental confederations for petangue. The CEP focuses on supporting its members, managing European petangue related projects and organising various annual events, including their European Championships of Triples, Doubles, Singles and precision shooting for men and women of all ages.

The initial design of the CEP was to provide a European Triples Championship for Juniors and Women in the year between their World Championships. In 1998 a junior championship was held in Dijon, France, which was followed in 2000 by the first official European Championship for Juniors in Liège, Belgium. The following year the 1st European Triples Championship for Women was held in Strasbourg.

During the European Congress (Denmark) in 2005, the CEP introduced the Espoirs Championship, specifically for adults under the age of 23 years. For a while there was no European Mens Championship, but in response to the FIPJP introducing a 48 team limit for the World Championship Men, the CEP decided to organise the 1st Mens Triples Championship in 2009 (Nice, France) as a method of gualification to find the 24 nations that would represent Europe at the World Championships.

In 2012 the Directors organised the first European Veterans Triples (55+) Championship in Hvidovre, Denmark, the only international championship for veterans, which makes up the majority number of members in each federation. To complement their Singles Championship, the CEP has added the Doubles Championships - Men. Women and Mixed, which sees its debut in s-Hertogenbosch, Netherlands 13 - 17 July 2022.

















DUTCH PETANQUE FEDERATION



The Dutch petanque federation, the NJBB (Nederlandse Jeu de Boules Bond), is a sports federation that stands and stands up for the interests of the petanque sport in the Netherlands and facilitates the sport nationally for different target groups at different levels.

VISION

The NJBB is the authority in the field of jeu de boules in the Netherlands and facilitates a suitable offer for practicing the jeu de boules sport for different target groups at different levels.

COURSE

In order to realize the mission and vision, the NJBB follows the course: petanque as a competitive sport. In the activities of the federation, the focus is on positioning and promoting competitive sport. For example, a new national competition has been developed (the National Petanque Competition), the quality of the National Championships has been improved, the NLpetanque sports platform has been launched, the training courses for referees, match directors and petanque instructors have been developed and a lot of attention has been paid to the district competitions. In order to achieve this, it is also important to put the association's organization in order and to organize activities more efficiently and with an eye for quality and continuity. As of January 1st 2017, a new organizational structure is in force, in which the forces are bundled and the sport is organized close to the association.



Team TOC is the local organizer of the European Petanque Championships 2022. TOC stands for The Organizing Connection. Our name says it all: we are the binding factor in any event's organization. From permits and licences to logistics and from sales to operation: we oversee it and make sure that everything fits seamlessly. That is the true secret of a successful event: the fact that we leave nothing to chance, because an event is much too valuable for that.

Team TOC was founded in 1998. In the past twenty years we gained a considerable amount of knowledge about organizing (large) sports events. Team TOC is known for its friendliness and hospitality. Its partners regard Team TOC as a loyal and enthusiastic partner to work with. We will give you an impression of the many sports events that Team TOC has already organized. Team TOC is already a familiar face in the cycling world. In addition to several UCI Cyclo-cross World Championships, Cyclo-cross World Cups and UCI BMX Supercross World Cups, we were also involved in the UCI Road World Championships in Limburg (the Netherlands), Florence (Italy) and Ponferrada (Spain). In 2016, we organized the AFAS Tennis Classics (Apeldoorn, the Netherlands) for the fifteenth time. We are also creative and together with Red Bull Netherlands we launched a new cycling concept in 2015, which was a huge success and ran till 2018. In addition to the various big events, we ventured into the Para world in 2015 and organized the UCI Para-Cycling Track World Championships, which we repeated in 2019. It was a busy year, because in 2019 we also organized the UCI Para-Cycling Road World Championships and the World Archery (Para) World Championships. True athletes showed us a lot of passion for their sport, which made us even more passionate about creating a perfectly organized event with specific needs.

After several big events in cycling, tennis and archery we came in contact with petanque. Once we saw this sport, we decided to set our sights on showing it to the rest of the world by organizing European Championships in the Netherlands. Organizing the 2022 European Petanque Championships will give us the opportunity to promote petanque in the Netherlands, to surprise the Netherlands and Europe by showing hem the attractiveness of petanque and to show how sports can connect people. Our sport is organizing events and taking care of everything behind the scenes the best way possible with our winning team. To do that we use our experience and network and of course the efforts of volunteers, the city and the National Federation, otherwise organizing European Championships would be impossible.

ACCOMMODATION

In and around the city of 's-Hertogenbosch we have selected two beautiful accommodations, especially for all participants in the European Petanque Championships. In total we can offer you four different accommodation packages, which all include:

- One parking ticket for the parking garage closest to the event venue -

- Reservation fee

The two accommodations are of the same level and they both meet the same high standard the organization has set for the entire event. One of them is located right in the heart of the city centre of 's-Hertogenbosch, while the other accommodation is located at the edge of the city, within biking distance of the city centre, in beautiful green surroundings.

Booking of accommodations open on November 1st 2021. Reservations can be made by completing the booking form on the event website: www.petanque2022.nl. Rooms are available on a first come, first serve basis. To all bookings the General terms and conditions - Accommodation as stated on page 14 apply.

PAYMENT CONDITIONS

To finalize the confirmation of an accommodation booking, the payment of a non-refundable deposit and a final payment are required. The deposit consists of 60% of the total amount and is to be paid by bank transfer before the stated deadline. The final outstanding balance of the remaining 40% should also be paid by bank transfer before the stated deadline. Please note that when not meeting these deadlines, availability of your accommodation cannot be guaranteed.

ACCOMMODATION PACKAGES

VAN DER VALK HOTEL 'S-HERTOGENBOSCH-VUGHT



The rooms are very spacious and equipped with comfortable beds, flat screen tv, air conditioning, coffee and tea facilities and a balcony or terrace. The bathroom has a bath and shower, hair dryer, toilet and bath products.

Free wi-fi is available all throughout the hotel and also the sports facilities are free to use. The large parking lot of the hotel is free to use for guests. The hotel has even created three petangue courts in its garden, perfect for some late night practise.

GOLDEN TULIP HOTEL CENTRAL



Golden Tulip Hotel Central is located at the market square in the heart of the city centre of 's-Hertogenbosch and just around the corner of the event venue.

The large rooms are equipped with comfortable beds, flat screen tv, air conditioning, coffee and tea facilities, minibar and radio. The bathroom has as bath and shower, hair drver and toilet.

Free wi-fi is available for all guests and the fitness centre is also free to use. The hotel doesn't have its own parking lot or garage. Teams that have booked their stay at this hotel via the LOC will receive a parking ticket to the Sint Jan parking garage. This parking garage is located at 10-15 minutes walking distance from the hotel. For more parking spaces, the hotel has arrangements with a next door parking garage. Hotel guests can use this garage at a reduced rate.



Van der Valk Hotel 's-Hertogenbosch-Vught is beautifully located in nature, with the city centre of 's-Hertogenbosch just a couple of minutes away.

LUNCH

Lunch is not standard included in the accommodation packages. Teams are free to make their own arrangements for lunch. However, the LOC does offer a lunch option. Golden Tulip Hotel Central is located very close to the venue. A sport lunch buffet is offered at a special rate.

This offer is applicable to all teams booking their accommodation via the LOC, so also to teams staying at Van der Valk Hotel 's-Hertogenbosch-Vught. On the booking form teams can indicate if they would like to use the lunch option. The option is always applicable to the entire stay and separate days cannot be selected. For both the package for 5 days and the package for 6 days lunch will be served from Thursday till Sunday (4x).





DINNER

The LOC offers a dinner option at both hotels at a special rate and includes a main course and one drink.

This offer is applicable to all teams booking their accommodation via the LOC. Dinner will always be served at the hotel the team is staying at.

On the booking form teams can indicate if they would like to use the dinner option. The option is always applicable to the entire stay and separate days cannot be selected. For the package for 5 days dinner will be served from Wednesday till Saturday (4x). For the package for 6 days dinner will be served from Wednesday till Sunday (5x).

Since the event venue is located in the city centre of 's-Hertogenbosch, there are also endless options to get a nice dinner within just a few minutes walking distance of the venue. TRANSPORT

Transportation from the accommodation to and from the event venue on event days is included in the hotel accommodation package for all teams who book their accommodation trough the LOC. Event days are Wednesday July 13th 2022 till Sunday July 17th 2022.

EVENT TRANSPORT

The event transportation options as stated below are applicable to teams who stay at Van der Valk Hotel 's-Hertogenbosch-Vught during the European Petanque Championships 2022. The second hotel, Golden Tulip Hotel Central is located in the city centre of 's-Hertogenbosch and within a 5 minute walking distance of the event venue.

The organization offers two types of transportation for teams who stay at Van der Valk Hotel 's-Hertogenbosch-Vught. Teams can choose one of these options. The team will only be able to use the option that is selected. Bikes and bus seats will be available based on requests made by teams on their booking form, there will not be spare bikes or seats.

BY BIKE

Travel the Dutch way by bike. Did you know that there are more bicycles in the Netherlands than people? The easiest transport option in the Netherlands is by bicycle. A bike will be available during the event days for you upon request. This way you are able to cycle wherever you want to go, when you want to go there.

The distance between Van der Valk Hotel 's-Hertogenbosch-Vught and the event venue at the Parade in the city centre is 2,9 km which means the route will take you about 10 minutes by bike.

BY BUS

A shuttle service will be available for transportation between Van der Valk Hotel 's-Hertogenbosch-Vught and the event venue at the Parade. More information about the bus service will be announced at a later time.

GENERAL TRANSPORT OPTIONS

Besides specific event transport, there are a few general transport options for both local transport as well as for your arrival in the Netherlands.

These options are not just applicable to teams staying at Van der Valk Hotel 's-Hertogenbosch-Vught, but also to teams staying at Golden Tulip Hotel Central.

LOCAL PUBLIC TRANSPORT

Local public transport in 's-Hertogenbosch is offered by bus. There is an extensive bus network throughout the city. If teams have used the morning shuttles to travel from their hotel to the event venue, the organization suggest public transport by bus to travel back (and forth) to their hotel in the afternoon or evening.

Teams can use local public transport by showing their event accreditation to the bus driver when entering the bus.

BY AIRPLANE

There are two large airports in the Netherlands that are most convenient to use when travelling to 's-Hertogenbosch. The biggest airport in The Netherlands is Amsterdam Airport, which is about an hour from 's-Hertogenbosch. Closer to the event city is Eindhoven Airport. This airport is a bit smaller, but covers a lot of European flights. Eindhoven Airport is about 30 minutes from 's-Hertogenbosch. More information about how the organisation will welcome and assist teams at the airport and train station will be announced at a later time.

BY TRAIN

After your arrival in the Netherlands, the train is an easy and convenient way to travel to 's-Hertogenbosch. From Amsterdam Airport the trip, directly from the airport to 's-Hertogenbosch central train station, will take approximately 1 hour. The entrance to the train station is located in the arrivals terminal at the airport. The costs are approximately ≤ 18 ,- per person for a 2nd class one way ticket. Book your ticket one month in advance on the website: www.ns.nl/en.



There is no train station at Eindhoven Airport. There is a bus stop, from where a bus can take you to Eindhoven central train station. From this train station, a direct train connection brings you in about 20 minutes to 's-Hertogenbosch central train station. The costs are approximately \notin 7,- per person for a 2nd class one way ticket. Book your ticket one month in advance on the website: <u>www.ns.nl/en</u>.

From the 's-Hertogenbosch central train station, there is a bus connection to Van der Valk Hotel 's-Hertogenbosch-Vught. The bus station is can be found by turning right when leaving the train station at city centre side and/or by following the 'bus' signs at the train station.

Golden Tulip Hotel Central is located within walking distance of the train station.

More information about how the organisation will welcome and assist teams at the airport and train station will be announced at a later time.









BY CAR

The Netherlands is a small country, which luckily means that distances are never very far and can easily be done by car. For example, a car ride from Amsterdam Airport to the 's-Hertogenbosch city centre takes just a little over an hour and from Eindhoven Airport even half of that.

The city of 's-Hertogenbosch is also very easily accessible by car. For more information about travelling by car to and parking at the hotels, see the accommodation information on page 8.

Every team that books their accommodation through the organization will receive 1 parking ticket to the Sint Jan parking garage. The address is Hekellaan 25, 's-Hertogenbosch. This is fairly new, the biggest parking garage in 's-Hertogenbosch and opened 24 hours a day, 7 days a week.
